Reception/Access Control/Registration – 300 SF

- Equipment (basketballs, pickleball paddles, etc) issued at this location?
 Additional space may be necessary for this function
- More space may be necessary as there is no staff workroom

Waiting Area – 300 SF

- According to the conceptual plan, this space is behind Access Control.
 How is this space different than Entry Lobby or Lounge? May be redundant?
- o Was this space related to Exam/Consultation?

Locker Rooms – 1,000 SF

- o This SF will accommodate approximately 30 full height 12" x 18"D lockers for each gender. Is this adequate?
- ROT for Locker facilities is 10-12% of overall facility SF. 30,000 SF = 3,000 SF for Lockers. This is trending downward.
- No aquatics is a consideration in ROT above
- Climate will have an impact...users may come in fitness attire
- Senior demographics have an impact on usage?
- Club-like higher end finishes and more spacious accommodations desirable?
- Day Lockers out in recreation spaces? Open Cubbies?
- Separate Family Locker Room recommended

Office – 120 SF

- Program description calls for 2 staff? 120 SF is tight
- o Plan illustrates this space separated from Access Control?

Multi-purpose Gymnasium – 12,000 SF

- Number of spectators for recreation events such as basketball tournaments?
- What other events might take place within this space? Small Concerts?
 Community Fairs? Lectures?
- 84' court dimension recommended (94' is a collegiate length). 2 courts at 50' x 94' need 14,000 SF. 2 courts at 50' x 84' need 13,000 SF

Lounge (Multi-generational) – 1,200 SF

- o How is this space related to Entry Lobby?
