Welcome to Camp!

GENERAL INFORMATION

AGES: Camp Funtastic welcomes boys and girls ages 5-11 years old. Campers will be divided into age appropriate groups.

HOURS: Camp Funtastic is open from 7:30am to 6:00pm, Monday through Friday. Traditional camp activities are held from 9:00am to 4:30pm and operated extended care activities from 7:30am to 9:00am and 4:30pm to 6:00pm. If you pick up your child after the 6:00pm closing time, there is a \$15 fee for every 15 minutes you are late. Example: If you arrive at 6:05pm you pay \$15. If you arrive at 6:16pm, you pay \$30.

CAMP RULES: Camp is designed to be a safe and fun environment for every child who participates in the program. Campers must treat everyone with respect. Behavior that is harmful or disruptive to the function of camp or other campers will not be tolerated.

DRESS CODE: Children must come to camp dressed appropriately for a day of physical activity. Students must come to camp in athletic shoes or soft soled shoes appropriate for physical activities. On the Tuesday field trip day, campers are required to wear their Camp Funtastic shirt. Campers may not wear open-toed shoes, boots, sandals, or clothing with inappropriate graphics or wording.

LUNCH: Please pack your camper with a lunch including a morning and afternoon snack. Also, please include a water bottle with you child's name on it for his/her hydration maintenance. On non-field trip days, you may send your child's lunch in a lunch box or cooler. On field trip days, campers must bring their lunch in either a paper lunch sack or plastic grocery bag with his or her name on it. A refrigerator or microwave will not be available at anytime.

HEALTH & SAFETY

CAMPER HEALTH: To protect all of the children at Camp Funtastic, any child who comes to camp ill or has a contagious medical condition may NOT attend camp. Children must be free of fever, rash, or other signs of contagious illness for 24 hours before returning to camp. If, during the course of the day, a child develops any signs of contagious illness including rash, vomiting, diarrhea, fever, or any signs of head lice, the parent or legal guardian will be notified and the child must be picked up immediately.

HEAD LICE: Camp Funtastic has a "NO NITS" policy. We will do periodic head checks for lice and we encourage parents to check their children before bringing them to camp.

MEDICATION: Only prescription medication can be administered by the camp staff. All medications must be presented to the camp staff in the original container at the time the child is signed in for the day. A "Permission for Administration of Prescription Medication" form must be completely filled out and signed by the parent or legal guardian before medication can be administered.

CHILDREN WITH SPECIAL NEEDS: Children with special needs are welcome at Camp Funtastic. Special needs (including allergies, dietary restrictions, and physical or mental challenges) should be noted on the registration form. For the well-being of all campers, camp participants must be able to abide by camp rules and participate in group activities. Accommodation will be assessed on a case by case basis. If your child requires medication, it must be noted on the registration form, and the procedure outlined above must be followed.

SIGN-IN & SIGN-OUT PROCEDURES: To ensure the complete safety of your child, campers may not sign themselves in or out. A parent, legal guardian, or authorized adult (age 18 or older) is required to drop off and pick up children. All campers must be signed in and signed out on the attendance roster. Only adults listed on your registration form are allowed to sign your child in and out. Photo ID will be required.

NOTICE OF MANDATED REPORTER STATUS: All Camp Funtastic staff, volunteers, and agents are designated a "Mandated Reporter" by the State of California. In accordance with California State Law, cases of suspected child abuse or neglect will be reported to the appropriate agency.

STAFF

Our active and excited staff make Camp Funtastic a great place to spend the Summer break. Staff is thoroughly trained on camp policies, safety procedures, active and passive games, arts & crafts, and athletic activities. All staff undergo fingerprinting and background checks. All staff are CPR and First Aid Certified. There are always lifeguards on duty when we are at the Pleasant Valley Aquatic Center.

REGISTRATION

REGISTRATION: Parents can enroll their children for 1 to 5 days per week. Enrollments are confirmed only when full payment is received and the registration form is completed. Please see the chart at the right for rates. Trip days are Monday, Tuesday and Thursday. In the event of inclement weather, Camp Funtastic may substitute an on-site guest in place of walking and/or pool trips. Late and drop-in enrollments are subject to availability. To register for Camp Funtastic, complete and sign the application form. Submit completed forms, along with the \$25 non-refundable, annual registration fee and enrollment fees for the first week of camp to the Pleasant Valley Recreation and Park District Administration Office, Fax to 805-482-3468, or mail to:

TRANSFERS: Requests for transfer must be received at least 1 business day in advance. Parents may transfer their child(ren) from one day to another, up to 10 times during the Summer season. Please be aware that if you do not transfer within the allotted "Camp Rates" time frame, you may be required to pay additional fees for a late transfer. Transfers beyond 10 will incur a \$5 cancellation fee.

REFUNDS AND CREDITS: All requests for refunds must be received at least 1 business day in advance. A \$5 (per day cancelled) fee will be deducted. Credits will either be refunded back to the credit card you paid with or a check will be issued within 3-4 weeks of your request.

SICK DAYS: Credit for sick days or other absences are NOT available.

CAMP ACTIVITIES

CAMP ACTIVITIES: Camp Funtastic is all about having FUN! Campers are supervised by trained camp counselors at all times. Campers will participate in a variety of exciting indoor and outdoor activities during the day. During regular camp hours (9:00am-4:30pm) activities are structured and include field trips, crafts, special events, group games, sports, parties, camp store, movies, and more. During the extended care hours (7:30am-9:00am & 4:30pm-6:00pm) campers will enjoy board games, coloring contests, legos and other free play activities. Each day will have a special activity. The "Funtastic Newsletter" will be provided to you each week with a schedule of events and guests.

FIELD TRIPS: Each Monday, Tuesday and Thursday, we will embark on a trip. All children registered for camp on trip days MUST attend field trips, as on-site care will not be provided during the trip. Campers must wear their camp shirts on Tuesday trip days. Each Monday and Thursday, campers must wear swim attire under their clothing. Children may be required to arrive at camp earlier than 9:00am on some field trip days. In these occurrences, your "Funtastic Newsletter" will inform you of these times. We're sorry but the bus cannot wait for tardy campers. Make sure you review your "Funtastic Newsletter" for updates. If you wish to send your camper with extra spending money for the field trip, you may give it to the staff member who is at the sign-in desk in the morning. It will be catalogued in a pouch for the camp counselor in charge of your camper's group. The remainder of the money will be returned to you at the end of the day usually with a receipt for the items purchased.

CAMP CASH: Camp Funtastic strives to teach all campers respect, responsibility, civic duty, and kindness. Funny Money is awarded for positive behavior, special service, a positive attitude, winning games and contests and activity participation. Funny Money can be redeemed for items in the camp store. Camp store prices range from \$1 to \$10. The Camp Store will be open on Thursdays and Fridays, so don't forget your "Camp Cash"!

FACILITIES

Camp Funtastic is held at the Camarillo Community Center at 1605 E. Burnley Street in Camarillo. Campers will enjoy the use of classrooms, open air patio facilities, park equipment, open air park, and use of the Monte Vista Gym Facilities. In the event of inclement weather or extreme heat, activities will be moved indoors.

Please read the following information carefully. Your signature indicates that you fully understand and agree to abide by the terms of Camp Funtastic.

This form must be signed in order to enroll in the Camp Funtastic program. The release may not be altered in any way.

TRIP AND ACTIVITY APPROVAL

I, the undersigned, grant permission to my child(ren) to attend all Camp Funtastic Excursions and Trips. I, the undersigned, hereby grant permission to my child(ren) to participate in Camp Funtastic activities including but not limited to sports, crafts, games, field days, and special events.

BEHAVIOR CODE

Good behavior is expected at all times. Behavior problems constituting actions harmful to others or disruptive to camp will be dealt with as follows: **First Incident**-Verbal warning to the child with a time out session. **Second Incident**-Parents will be notified. **Third Incident**-Child will be denied (suspended) from participation in camp or field trip. Camp Funtastic and the Pleasant Valley Recreation and Park District reserves the right to expel a camper immediately for behavior harmful to other campers. Unacceptable behavior and/or abusive language by parent or guardian may also result in a child being expelled. No refunds will be issued for missed excursions, activities or expulsion from camp. I, the undersigned, have read these rules and agree to the terms of Camp Funtastic's behavior code.

INFORMED CONSENT AND RELEASE

I, the undersigned, voluntarily participating in the referenced activity, understand that such participation does not establish or imply an employer-employee or an agency relationship with the Pleasant Valley Recreation and Park District. I acknowledge and agree that some activities may be of a hazardous nature and/or include physical and/or strenuous exercise or activity and understanding this I state that I have no knowledge of any conditions that would prohibit my child from safely participating. Please note: The Pleasant Valley Recreation and Park District does not provide any insurance coverage of any kind for your participation. The Pleasant Valley Recreation and Park District strongly recommends that appropriate insurance be obtained by each participant.

I, the undersigned, and in the event that the undersigned is under 18 years of age, the undersigned's parents or guardian, in consideration of the request and permission to participate in the referenced activity, hereby assume full responsibility for all risk of injury or loss which may result from my participation in this activity and hereby AGREE TO DEFEND, INDEMNIFY, HOLD HARMLESS, RELEASE AND FOREVER DISCHARGE the Pleasant Valley Recreation and Park District, from any and all acts of negligence and all claims and demands whatsoever, which the undersigned, any third person, or any persons acting under their behalf, have or may have against the Pleasant Valley Recreation and Park District, by reason of any accident, illness, injury to or death of any person or persons, or damage to or loss or destruction of any property arising or resulting directly or indirectly from participation in the referenced activity and occurring during said participation, or any time subsequent thereto. The terms of this release will serve as a release and assumption of risk for my heirs, executors and administrators and for all of my family members.

PERMISSION FOR MEDICAL TREATMENT & TRANSPORT

I, the undersigned, hereby grant the Pleasant Valley Recreation and Park District and agents thereof, permission to summon 911 in the event that myself or my child(ren) require advanced first aid or medical treatment. I further grant permission to transport myself or my child(ren) to another center of advanced care. I grant permission to any and all physicians, surgeons, medical personnel, and emergency medical technicians or paramedics to treat myself or my child(ren) if such treatment is reasonably required.

CAMP HOURS AND EXTENDED CARE POLICY

Camp Funtastic hours are from 9:00am-4:30pm Monday through Friday. Extended care hours are from 7:30am-9:00am and 4:30pm-6:00pm Monday through Friday. Children must be dropped off no earlier than 7:30am. Children must be picked up no later than 6:00pm. I understand that there is and agree to pay a \$15 for every 15 minutes, or part thereof, that my child(ren) attends camp beyond these hours. **Notice:** Under no circumstance may any child be left at the camp facility unattended. Parents MUST sign children in and out of camp. I, the undersigned, have read, understand, and agree to abide by the Camp Hours and Extended Care Policy.

PHOTOGRAPHIC RELEASE

I grant the Pleasant Valley Recreation and Park District at its discretion and free of charge, permission to use still photography of myself or my child(ren) participating in District sponsored recreation programs for the purpose of publicizing said programs.

REFUND, CREDIT, AND CANCELLATION POLICY

I, the undersigned, agree to abide by the terms and conditions outlined in the Refund, Credit, and Sick Day policy. I agree to have deducted from any refund a \$5.00 per day cancellation fee. I realize that no credit, refund, or transfer will be given without a minimum of one business day notice. I further understand that credits, refunds, or transfers will not be given for sick days or other absences.

REGISTRATION POLICY

I, the undersigned, agree to abide by the terms and conditions outlined in the Registration policy. I understand that the Pleasant Valley Recreation and Park District office staff must receive registrations a minimum of five business days in advance in order to qualify for the regular camp rate and guarantee a space in camp. I understand that registrations received with less than five business days notice will be accepted at a higher rate and are subject to availability.
