Pleasant Valley Aquatic Center Party Rules and Regulations

1. A \$100 non-refundable deposit is due at the time of reservation. Make check payable to "PVRPD."
2. All fees must be paid 7 business days prior to the reservation. Make check payable to "PVRPD."
3. No refunds will be given if the party is cancelled less than 7 business days prior to party date.
4. The parent organizing the party may arrive 30 minutes prior to the start of the party for set-up.
5. In case of inclement weather, you may transfer your party to another available day.
6. Alcohol may not be served, nor may any person appear in the facility in an intoxicated condition.
7. No smoking in the facility.
8. No glass may be brought into the facility.
9. All regular pool rules are enforced. If you would like a list of the pool rules, please notify management, and we will provide you a copy.
10. Party guests must pass a swim test in order to use the deep end, slide (7+ years old), and diving board.
11. No water wings allowed. Only Coast-Guard approved life jackets with a strap between the legs are permitted.
12. All other floats and toys must be cleared with management.
13. Active, in-water supervision by parent/guardian may be required for non-swimmers.
14. Outside party materials (including decorations and food) may be brought in by the parent organizing the party. One refrigerator shelf available for use. Coolers may be brought in addition. All food and decorations brought by party parent must be cleaned up by the end of the party.
15. The parent organizing the party may not leave the party site until all minors have been picked up. PVRPD is not responsible for any children after the conclusion of the party.
